Please find attached to this cover letter a Notice of Intent to Circulate Referendum Petitions on Ordinance Number 160281 advanced and passed by the City Council on April 28, 2016. This Notice of Intent has been signed by over 100 electors of Kansas City, Missouri, signifying the intent of the Committee of Petitioners to circulate referendum petitions.

We represent several property owners throughout Kansas City who have great concerns regarding the amendment made to the Liquor Code that diminish the ownership interests of properties that are owned by a single or related entity/person as they apply to the issuance of liquor licenses. These changes were made without any input from these property owners and no notice was provided to them of the opportunity to attend the Alcoholic Beverage Advisory Group or the City Council's Neighborhood and Public Safety Committee to discuss the proposed changes. In fact, a request to allow a one week continuance at the City Council meeting last week was even denied to allow the members of the City Council the opportunity to hear the concerns of these property owners. We are hopeful that continued discussions may address the concerns of all involved in the amendments to the Liquor Code passed through Ordinance No. 160281.
